

## **Dance Studio Terms & Conditions (Kids & Adults, In-Studio & Online)**

### **1. Enrollment & Registration**

- All students must complete registration before attending classes.
  - Students under 18 must be registered by a parent or legal guardian.
  - Enrollment is confirmed upon payment.
  - The studio reserves the right to refuse or cancel enrollment.
- 

### **2. Fees & Payments**

- Fees must be paid in advance (monthly/term basis).
  - Fees are non-refundable and non-transferable unless approved.
  - Missed classes (in-person or online) are not refundable.
  - Late payments may result in denied access to classes.
- 

### **3. Attendance & Punctuality**

- Students must arrive/log in on time.
  - Late entry may be restricted for safety and class flow.
  - Make-up classes are subject to availability and approval.
- 

### **4. Parent/Guardian Responsibilities (For Minors)**

- Parents/guardians must supervise children during online classes where appropriate.
  - Ensure timely drop-off and pick-up for in-studio classes.
  - The studio is only responsible during scheduled class time (physical or virtual).
  - Emergency contact details must be current.
- 

### **5. Online Class Policy**

- Students are responsible for having a stable internet connection and a suitable device.
  - The studio is not responsible for technical issues on the student's side.
  - A safe, clear space must be used for dancing at home to prevent injury.
  - Classes may be conducted via platforms such as Zoom or similar services.
  - Login details must not be shared with others. Unauthorized access may result in removal.

## **6. Recording & Digital Use**

- Online classes may be recorded for quality, training, or replay purposes.
  - Students must not record, distribute, or share class content without permission.
  - Any shared recordings are for personal use only.

## **7. Code of Conduct**

- Respectful behavior is required in both physical and virtual classes.
  - Disruptive, inappropriate, or unsafe behavior may lead to removal without refund.
  - Proper attire and readiness to participate are expected (including online).
- 

## **8. Health & Safety**

- Students must disclose any injuries or medical conditions.
  - Participation is at their own risk (including at-home participation).
  - Students should not attend if unwell or injured.

## **9. Liability Waiver**

- The studio is not liable for:
  - Injuries during in-studio or online classes (except proven negligence)
  - Injuries caused by unsafe home environments during online classes

- Loss or damage of personal belongings
  - Parents/guardians accept responsibility for minors, especially in online settings.
- 

#### **10. Class Changes & Cancellations**

- Classes may be rescheduled, moved online, or canceled if necessary.
  - Notice will be given where possible.
  - Credits or alternatives may be offered at the studio's discretion.

#### **11. Photography & Media Consent**

- Photos/videos may be taken in-studio and online for promotional use.
  - Consent is required for minors; opt-out must be submitted in writing.

#### **12. Performances & Events (If Applicable)**

- Events may include both in-person and virtual performances.
  - Additional fees, rehearsals, and commitments may apply.
- 

#### **13. Intellectual Property**

- Choreography and teaching materials remain the studio's property.
  - Unauthorized sharing, recording, or reproduction is prohibited.
- 

#### **14. Termination of Enrollment**

- The studio may terminate enrollment for violation of terms.
  - No refunds will be issued in such cases.

#### **15. Privacy Policy**

- Personal information is used only for administration and communication.

- Online platforms may collect limited data per their own policies.
  - The studio will not share personal data without consent unless required by law.
